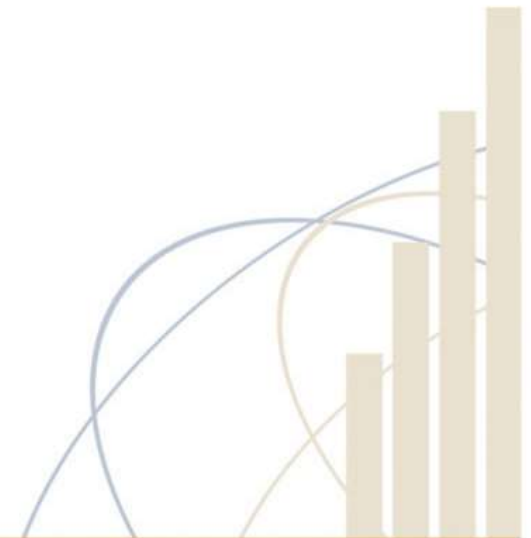

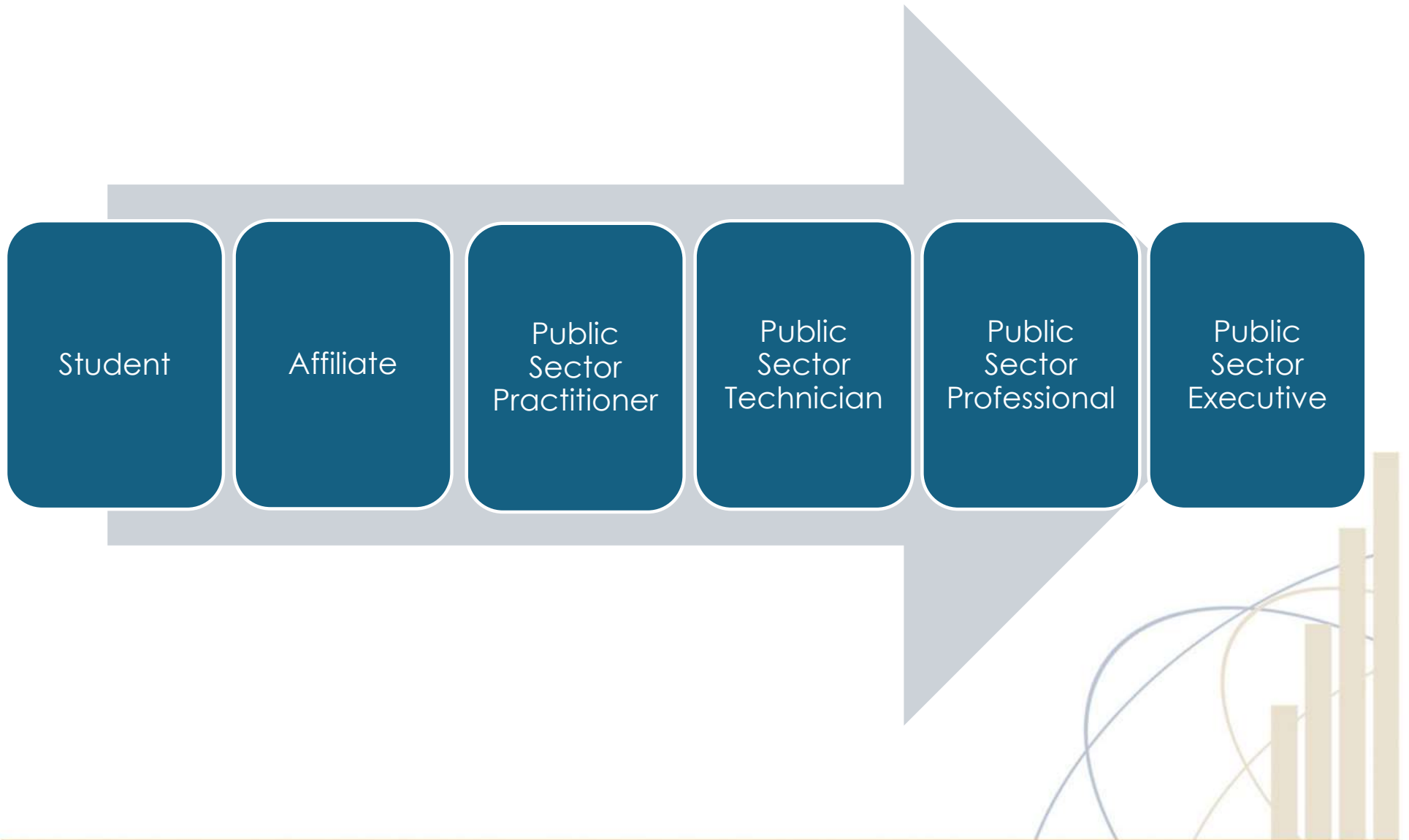

Membership Requirements

Public Sector Practitioner (PSP (SA))

NQF Level 4
Minimum of 6 Months experience

Public Sector Technician (PST (SA))

NQF Level 6
4 years of which at least 2 years must have been on Junior Management (or higher) level
5 years at any level in a role related to the position in the Public Sector

Public Sector Professional (PSPro (SA))

NQF Level 7
Minimum of at least 5 years at Middle Management

Public Sector Practitioner (PST (SA))

NQF level 8
7 years Senior Management level in the Public Sector

Affiliated Member

Who can apply? (Any person/s who is involved in finance, audit, risk management and performance management matters but do not have a related qualification)

Student

Must be full-time studying in Finance/Auditing Risk Management or related qualification at a Tertiary Institution and must not be employed.
